I have no objection in principle to this application as the arboricultural impact is likely to be negligible subject to it being undertaken in accordance with the protection measures outlined in the accompanying arboricultural report. A single high category tree is proposed for removal, but its loss will be of limited significance within the wider landscape, and suitable methods for trees scheduled for retention have been recommended.

If you are minded to recommend approval, we will also require a detailed Arboricultural Method Statement, including an auditable monitoring schedule, and Tree Protection Plan, in order to ensure the mitigation measures are implemented effectively, this can be dealt with under condition.
